
Facilities Condition Assessment



Facilities Condition Assessment

> deficiencies, designing and prioritising repair or replacement activities, and providing cost modelling services for corrective measures.



detection and diagnostics and that deliver actionable insights and financial evaluations to enhance the efficiency of facilities management.



Asset information model



Transition Management




Overseeing testing and compliance procedures, compiling asset information, automating commissioning, and facilitating effective handover, to ensure that facilities operate on high performance from day one.

- Collecting and compiling all relevant asset data, centralising data with asset information models (AIM) and BIM-enabled common data environment (CDE) and developing or procuring customised training programs to facilitate operating and maintaining complex equipment.
 - Preparing comprehensive and tailored operation and maintenance tender documents, establishing precise preventative maintenance instructions, assigning key performance indicators (KPIs), and conducting thorough bidder prequalification and tender evaluations
- Providing sustainable commissioning services that include witnessing and verifying electromechanical systems, controls and building envelope function as designed and in compliance with codes and certification requirements (e.g. LEED fundamental commissioning, LEED enhanced commissioning, etc.)






